

School Breakfast Changes 2023-24 and 2024-2025 School Years

Starting September 1st, 2023* – The 88th Texas Legislature allocated funding to cover the fee of reduced-price breakfast through the 2024-2025 school year.

* Reduced-price breakfasts served at no cost prior to September 1, 2023, will not be reimbursed by the state.

Reduced-Price Breakfast Guidance for Schools Operating Universal Breakfast

Universal Breakfast = all students served breakfast at no cost

- All UB schools, even those NOT mandated, will automatically receive \$0.30 per reduced price breakfast claimed.
- Must opt-out if you do not want State reimbursement

- Site application will show \$0.00 for both paid and reduced-price meals



REMINDER!!!! If charging for paid students for breakfast...

- Site application should reflect:
 - Paid breakfast Actual cost being charged to students
 - Reduced-price breakfast Amount of reimbursement expected from the state per reduced-price breakfast claimed.

Three Options for Serving Students during an Unanticipated School Closure

Option 1 – SFSP or SSO

- Only available for USCs occurring between October and April.
- All area eligibility requirements are in effect for SY 2023-2024.
- Non-congregate service, parent pick-up, and meal service time flexibilities available.
- Service can be at the closed school site, if available.
- Flexibilities available up to a maximum of 10 days unless an approved extension is granted.

Three Options for Serving Students during an Unanticipated School Closure

Option 2 – CACFP At-Risk

- Anytime in the school year up until June 30.
- One meal and one snack.
- All area eligibility requirements are in effect for SY 2023-2024.
- Non-congregate service, parent pick-up, and meal service time flexibilities available.
- Enrichment is waived.
- Service can be at the closed school site, if available.
- Flexibilities available up to a maximum of 10 days unless an approved extension is granted.



Three Options for Serving Students during an Unanticipated School Closure

Option 3 – NSLP/SBP

- Anytime in the school year up until June 30.
- Virtual instruction must be provided.
- Non-congregate service, parent pick-up, and meal service time flexibilities available.
- Service can be at the closed school site, if available.
- Flexibilities available up to a maximum of 10 days unless an approved extension is granted.

Final Rule Lowering CEP Threshold

Proposed Rule to Lower CEP Threshold What's included?

Lowers the ISP threshold for schools to participate in CEP from 40% to 25%.

- Identified Student Percentage (ISP) = % of students certified eligible for free meals without the household application.
- Participation threshold = minimum ISP required to operate CEP.
- CEP may be implemented at individual school(s), groups of schools, or district-wide if the combined ISP is at or above the participation threshold.
- All students eat for free under CEP.
- Percentage of meals reimbursed at the free rate = (ISP x 1.6)
- Four-year cycle



Final Rule to Lower CEP Threshold What's included?

- The "grace" year threshold is 15% and over.
- Goes into effect for SY 2024-2025 based on ISP data submitted in the Spring CEP report.




Final Rule to Lower CEP Threshold Considerations

- ISP multiplier of 1.6 is not changing.
 - Ex. A school with 25% ISP operating CEP will receive free reimbursement rate for 40% of the meals claimed (25% x 1.6). The remaining 60% will be reimbursed at the paid rate.
- Any CNP program costs not covered by reimbursement must be paid for with non-Federal funds.

Verification Letters Sample Templates Suite
