Members of the Legislature:

Thank you for the opportunity to present this report on participation in the Summer Nutrition Programs (SNP). Our state is strategically utilizing federal resources to help alleviate hunger among Texas children during the summer months through the SNP. As required by SB 89 (82nd Texas Legislative session), the enclosed report presents findings on school district participation in the SNP.

The Texas Department of Agriculture (TDA) acquired these federally funded programs from the Texas Health and Human Services Commission in 2008. TDA continues to support & monitor these programs to ensure they are operated as intended. TDA provides school districts resources and materials, such as best practices and training, to help ensure the SNP are functioning efficiently and effectively. TDA is committed to continue working with statewide partners to identify private entities that can better serve summer meals to children in-need while reducing the burden on school districts that are mandated to participate in the SNP.

It is my hope that by providing this information, we will be able to help school districts overcome challenges to better provide summer meals to children in-need across the state of Texas.

Executive Summary

Texas law mandates that public school districts with 50 percent or more of their students eligible to receive free or reduced-price meals in the National School Lunch Program (NSLP) participate in the Summer Nutrition Programs (SNP) or request waiver from participation, per Senate Bill 89 (82nd Texas Legislative session). In 2015, 729 school districts were identified as mandated, of which 70 percent offered an SNP or arranged for the provision of an SNP. In 2016, 695 school districts were identified as mandated, of which 70 percent offered an SNP or arranged for the provision of an SNP.

Challenges remain for districts as the number of districts seeking waivers from their obligation to participation in an SNP has risen, from 201 in 2013 to 207 in 2016. According to waiver requests, transportation barriers are the single largest obstacle keeping school districts from participating, representing 54 percent of the waivers in 2015 and 64 percent in 2016.

Although schools continue to be the focus of outreach efforts to increase the number of summer feeding sites in Texas, recruiting new sponsors from the private non-profit sector and governmental entities is equally important.

Charge

In 2011, the 82nd Texas Legislature passed Senate Bill 89, directing the Texas Department of Agriculture to submit a biennial report regarding participation the summer feeding programs. This requirement replaced Texas Human Resources Code, section §33.024 with Texas Agriculture Code, section §12.0029 under the heading SUMMER NUTRITION PROGRAM, which stated as follows:

- (j) Not later than December 31 of each even-numbered year, the department shall provide to the legislature by e-mail a report that, for each year of the biennium:
 - (1) states the name of each school district that receives a notice under Subsection (c) and indicates whether the district:
 - (A) has provided or arranged for the provision of a summer nutrition program; or
 - (B) has not provided or arranged for the provision of a program and did not receive a waiver:
 - (2) identifies the funds, other than federal funds, used by school districts and the state in complying with this section; and
 - (3) identifies the total amount of any profit made or loss incurred through summer nutrition programs under this section.
- (k) The department shall post and maintain on the department's Internet website the most recent report required by Subsection (j).

Background

Texas Senate Bill 714, enacted by the 73rd Legislature in May of 1993, amended Chapter 33 of the Human Resources Code by adding Section §33.024, Summer Food Service Program (SFSP). The amendment requires school districts with 60 percent or more of their children eligible for free or reduced-price meals in the National School Lunch Program (NSLP) to participate in the SFSP by the summer of 1997. Mandatory participation is required only if federal funds are available to cover the cost of operating the program. School districts can be granted waivers from participation annually if certain conditions stipulated in the legislation are applicable.

Required participation was implemented incrementally by schools on an annual basis, beginning in 1994 with schools having 90 percent of their children eligible and ending in 1997 with schools having 60 percent of their children eligible. Public Law 108-265, the Federal Child Nutrition and WIC Reauthorization Act of 2004, made a number of changes to the Child Nutrition Programs, including provisions for a permanent summer feeding program through the NSLP as well as simplifications to the existing SFSP. Together, the two programs are referred to as Summer Nutrition Programs (SNP).

In 2011, Texas Senate Bill 89, enacted by the 82nd Legislature, amended Chapter 12 of the Agriculture Code by adding Section §12.0029 and repealing Human Resources Code, section §33.024. Senate Bill 89 requires that starting in summer 2012, public school districts with 50 percent or more of their students eligible to receive free or reduced-price meals in the National School Lunch Program (NSLP) participate in the Summer Nutrition Programs (SNP) or request waiver from participation. Further regulations are codified in the Texas Administrative Code, Title 4, Part 1, Rule §25.612.

Simplified Summer Food Service Program: Public Law 108-265 also expanded provisions of the 14-state pilot program of the simplified SFSP, which originated in 2001, to six additional states with low participation rates and established permanent simplified cost accounting procedures for all sponsors to include schools and non-profit organizations. The complex reimbursement formulas were replaced with a straight "meals times rate" provision that allowed maximum reimbursement regardless of actual cost.

NSLP Seamless Summer Option: The Child Nutrition and WIC Reauthorization Act of 2004 authorized a Seamless Summer Option (SSO) through the NSLP as an alternative to the SFSP for schools that already participate in school meal programs and wish to continue meal service into the summer. The Seamless Summer Option operates according to the same procedures followed during the school year except free reimbursable meals must be available for all children 18 years and younger in the area. There is no cost accounting procedure required for public schools electing to operate the Seamless Summer Option, other than those required for operating the NSLP. When the Seamless Summer Option became available, schools that are required to offer summer feeding were given the choice to participate in either the SFSP or Seamless Summer Option to meet the requirement.

In 2007, the Texas Department of Agriculture (TDA) administered the Seamless Summer Option while the Texas Health and Human Services Commission (HHSC) administered the SFSP. As of

September 1, 2007, when the administration of both programs came under TDA's purview, TDA became responsible for executing Senate Bill 714, managing the waiver process for mandated participation schools and submitting biennial reports to the legislature in even-numbered years.

Participation

In 2015, a total of 729 school districts were subject to the requirements of Senate Bill 89 (82nd Texas Legislature) with at least 50 percent of their students eligible for free or reduced meals. Of those 729 school districts, 507 participated in either the Summer Food Service Program or Seamless Summer Option.

In 2016, a total of 695 school districts were subject to the requirements of Senate Bill 89 (82nd Texas Legislature) with at least 50 percent of their students eligible for free or reduced meals. Of those 695 school districts, 488 participated in either the Summer Food Service Program or Seamless Summer Option.

Mandatory school districts are required to work with the state agency to remove barriers to participation, locate alternate sponsors and process waiver requests. In both fiscal years 2015 and 2016, all mandatory school districts participated in a Summer Nutrition Program or received a waiver to program participation, as the following tables show.

Waivers

School districts were granted waivers for the following reasons:

- Enrollment includes fewer than 100 children
- The cost of transportation is an insurmountable financial obstacle
- School buildings or cafeterias are under renovation or construction
- An alternate provider already sponsors a Summer Nutrition Program in the area, or the state agency accepted that there were other extenuating circumstances
- School Food Authority is unable to operate a summer nutrition program because the
 projected operational expenses for the summer feeding program exceed the expected
 federal reimbursements plus one month of the school food services' three months
 operating expenses on hand

Costs

School districts that had 50 percent or more students that met free and reduced eligibility are asked to report to TDA the total cost of operating their summer nutrition program once it has concluded, as well as any other funds (other than Federal funds) that were used to pay for the operation of a summer feeding program. From that self-reported information, TDA has deducted the amount of the federal reimbursements made for that year's program to create the lists of profit/loss, compared to federal funds received, incurred by the school districts and the state in order to comply with this section. Also reported are any other non-federal funds used to operate the programs. Those district costs are given in Appendix B (2015) and Appendix D (2016) for the districts that reported them. TDA did not incur costs above federal funds.
