New Releases

Noncongregate Extreme Heat Waiver

- Sites are outdoors and exposed to the weather.
- No alternative, temperature-controlled locations at which to provide congregate summer service.
- The National Weather Service (NWS) has issued a Heat Advisory, Excessive Heat Warning, or Excessive Heat Watch for the area.

New Releases

Noncongregate Extreme Heat Waiver

- One request form per day (multiple sites can be submitted per form)
- Must be grab-n-go and served directly to children DAILY.
 - Parent pick-up NOT allowed.
 - Multi-day bundling NOT allowed.
- Do **not** need to indicate intent to participate in the site applications.

Reimbursement Rates

2023-2024 CACFP reimbursement rates published to SquareMeals:

- https://squaremeals.org/Programs/Childand-Adult-Care-Food-Program/Reimbursement-Rates
- Extra \$0.10 per meal and snack by the Keep Kids Fed Act expired June 30, 2023.
- Provision allowing all Tier 2 Day Care Homes to be reimbursed at the Tier 1 rate expired June 30, 2023.
- New rates reflect an adjustment to the base rate from Program Year (SY) 2022–2023.



End of COVID-19 Flexibilities

Ended June 30:

- Offsite monitoring waivers
 - For allowable offsite flexibilities and strategies: https://www.fns.usda.gov/cn/oversight-monitoring-onsiteoffsite-cacfp-guidance
- Keep Kids Fed Act (KKFA) per meal higher reimbursements and Tier 1 reimbursement for Tier 2 day care homes.
- Non-congregate waivers in the event of a COVID outbreak.
