





Important Deadlines

- 1. LFS Fund Survey November 2024
- 2. Last day to make LFS purchases March 31, 2025
- 3. Last day to submit LFS reimbursement requests May 9, 2025

Notifications

- Email approval will be sent when Finance approves, the link to the Smartsheet won't allow you access.
- Reimbursement should be received within 30 days of Finance approval
- Search for payments on Comptroller's Search State Payments

Best Practices

- Submit the <u>Payment Request Form in excel spreadsheet</u>
- Only fill out the "itemized invoice" tab
- Put invoice attachments in same order as listed on the Payment Request Form when possible
- Consolidate reimbursement requests if it's the same vendor
- Bank statements aren't required
- Submit photos and recipes
- For Farm to Table LLC, and Common Market Invoices, you DO NOT need to separate it out by farmer/producer
