MENU Module Off-boarding

Procurement Tips

TDA held a webinar in September to relay best practices for procuring new menu analysis software. Please see below for key points from the webinar:



- Formal procurement is not required if the software costs less than \$50,000 annually.
- Using the small procurement method, solicit 2 or 3 vendors with your specifications and have them submit a quote.
- In the scope of work, provide an introduction of who you are, why you need this service (our current FREE service is being discontinued) and then bullet point what you need the software to do.
- If you want data such as the ingredients list, nutrition facts label and recipes in MENU to transfer seamlessly into the new system you need to state it in the specification, generally this will add more cost to the purchase.
- This purchase is not a sole source circumstance because there are many companies that provide this service/software.
- If you only receive one quote from your solicitation, you can award and purchase.
- Going manual with paper is also allowed for menu analysis.
