1. Review your current entitlement

Determine what you have left to use in SY 22-23 by visiting the Weekly Commodity Bulletin in TX-UNPS.

2. Can you use surplus

Do you have extra entitlement? Go into TX-UNPS and view reports. See if there are foods in surplus you can bring in and incorporate into your menus.

3. Submit the participation attestation form by clicking <u>here</u> or found on the first page

Fill out the attestation after completing steps 1 &2. TDA will use reports to determine if participants meet the challenge parameters: receive 95% of the allocated entitlement

4. Complete the End-of-Challenge survey that will be sent May 1, 2023

Steps to Complete the Challenge for SY23-24:

1. Watch the training video to help you understand your contract package

Ensure you have the foundational knowledge of understanding your contract package in TX-UNPS by watching the hour-long training video.

2. Review the "Bang for Your Buck" resource

Review the tips found in the resource to ensure that you are fully utilizing your entitlement

3. Determine how much regular USDA Foods aka brown box can be used in your menus

Determine if your menu can incorporate regular USDA Foods. Regular USDA Foods or brown box items need prep and recipes to utilize them. The Institute of Child Nutrition (ICN)'s <u>Recipe Box</u> has student approved, standardized recipes.

4. Use commodity calculators provided by processors to determine how much entitlement is needed for processing or if in a coop use ProcessorLink pre-order module

Determine how much to send to processors using their <u>commodity calculators</u>.

5. Submit the participation attestation form by clicking here

Fill out the attestation after completing steps 1-4. TDA will use reports to determine if participants meet the challenge parameters.

6. Complete the End-of-Challenge survey that will be sent May 1, 2023
