**2025 Summer Food Service Program Reimbursement Rates Published** 

USDA has published the 2025 Summer Food Service Program (SFSP) reimbursement rates. The new rates, which reflect a 3.6% increase from 2024, are published on the <u>Summer Meals Reimbursement Rates</u> webpage.

### Required Training for Summer Food Service Program (SFSP)

All new and returning Contracting Entities applying to operate SFSP are required to complete <u>annual training</u>. TDA provides three different options that will satisfy the requirement:

- A. Self-paced training
- B. Instructor-led training through regional Education Service Centers (ESCs)
- C. Virtual, instructor-led Training via SFSP Live at the ESCs.


At a minimum, the sponsor's supervisory personnel responsible for the food service must complete SFSP program administration and operations training and upload the certificate of completion with the application.

# <u>Update on Quarterly Community</u> <u>Calls</u>

TDA Food and Nutrition has discontinued its scheduled quarterly meeting for contracting entities (CEs) in the Child and Adult Care Food Program and Summer Food Service Program.
