### New Milk Flexibility for Emergency Conditions Notification Form

Considering recent milk supply chain issues due to packaging shortages, TDA is using the discretion provided by federal regulation to allow Program operators to serve and claim meals without fluid milk or with an alternate form of fluid milk during this temporary emergency period. To utilize the flexibility, Contracting Entities (CEs) affected by the recent shortage must submit the newly released Milk Flexibility for Emergency Conditions Notification Form as soon as possible. #### New Good Cause Transfer Request Form and Tutorial Released Online

TDA has streamlined the submission of Good Cause Transfer requests for CACFP sites by creating a new online request form **available here** and on the **CACFP Administration/Forms** page.
