NSLP-USDA Foods Inventory and Contract Management

- TX-UNPS will not be used for SY25 orders. It is currently closed for all State Contracted Warehouses.
- Your State Contracted Warehouse inventory system will be the inventory system used for SY25, so it is highly important that training has been completed. Ask system questions directly to their staff.

- Ensure you are organizing your current storage space to make room for your SY25 USDA Foods and monitor your inventory in conjunction with your menu planning. If you have any questions regarding your menus and/or inventory, contact your Education Service Center representative.
- As a reminder, keep your USDA Foods inventory levels less than 6 months on hand to maintain compliance with NSLP for SY25.
- Ensure all invoices are paid within 30 days of receiving your inventory/private storage fees.
- TDA is currently reviewing SY25 Private Storage reports from all FDP Regions and may have State Contracted Warehouses force ship some inventory to your sites.
- If you have any questions regarding your WBSCM reports, contact your Education Service Center representative for assistance.

FSMC New RFP/Contract and Renewal Contract Timeline

SFAs looking to begin a contract with a Food Service Management Company (FSMC) or renew an existing FSMC contract must adhere to TDA timelines. Visit SquareMeals.org/FSMC and look for Important Dates.

TANS Update

The Texas Automated Nutrition System (TANS) will replace TX-UNPS for administration and management of all programs beginning with Program Year 2026 applications. Timelines, resources, and updates are available now on the **Systems Hub**.

Attachment B Upload

The Attachment B Upload module is found under the "Applications" tab in TX-UNPS. To complete the Attachment B Upload, the SFA must:

- Indicate whether they are using the TDA template school meal application,
- Upload the school meal application used by the SFA during School Year 24-25
- Upload the instructions to the school meal application
- Certify the Attachment B Upload module in TX-UNPS
- Submit the Attachment B Upload module.

Verification Report Timeline

- October 1, 2024: SFA counts approved school meal applications on file.
- October 31, 2024: SFA counts the number of students with approved school meal applications on file.
- November 1, 2024: 2024 Verification Report opens via jot form: https://form.jotform.com/241276986330159. SFAs without school meal applications may begin submitting the Verification Report.
- November 15, 2024: Federal verification deadline. The verification process must be completed by this date. SFAs with school meal applications may begin submitting the Verification Report.
- November 26, 2024: Due date for the SFA's submission of the Verification Report.

TDA Launches the 2024 USDA Foods Challenge!

The Texas Department of Agriculture will launch the 2nd Annual USDA Foods Challenge! All schools who receive USDA Foods entitlement dollars will be automatically registered.

What is the USDA Foods Challenge?

The 2024 USDA Foods Challenge recognizes school nutrition teams for maximizing their USDA Foods entitlement. Schools utilizing at least 95% of their allocated entitlement will earn special TDA recognition. TDA is holding this challenge to recognize your commitment to achieving excellence in school nutrition.

- SY 2024-2025


