## MAY 2024

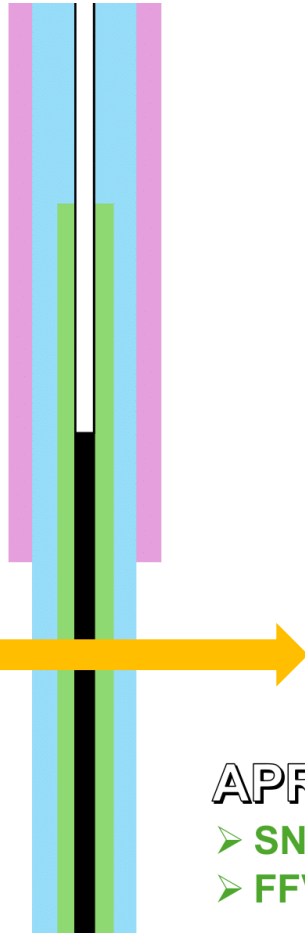
### Development Begins

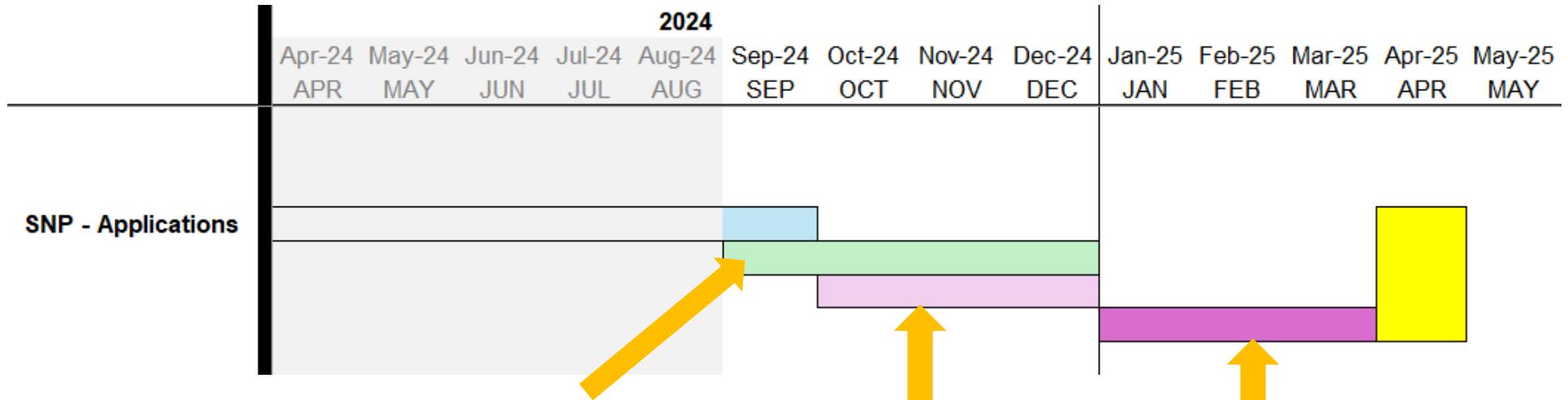

**TANS Development**

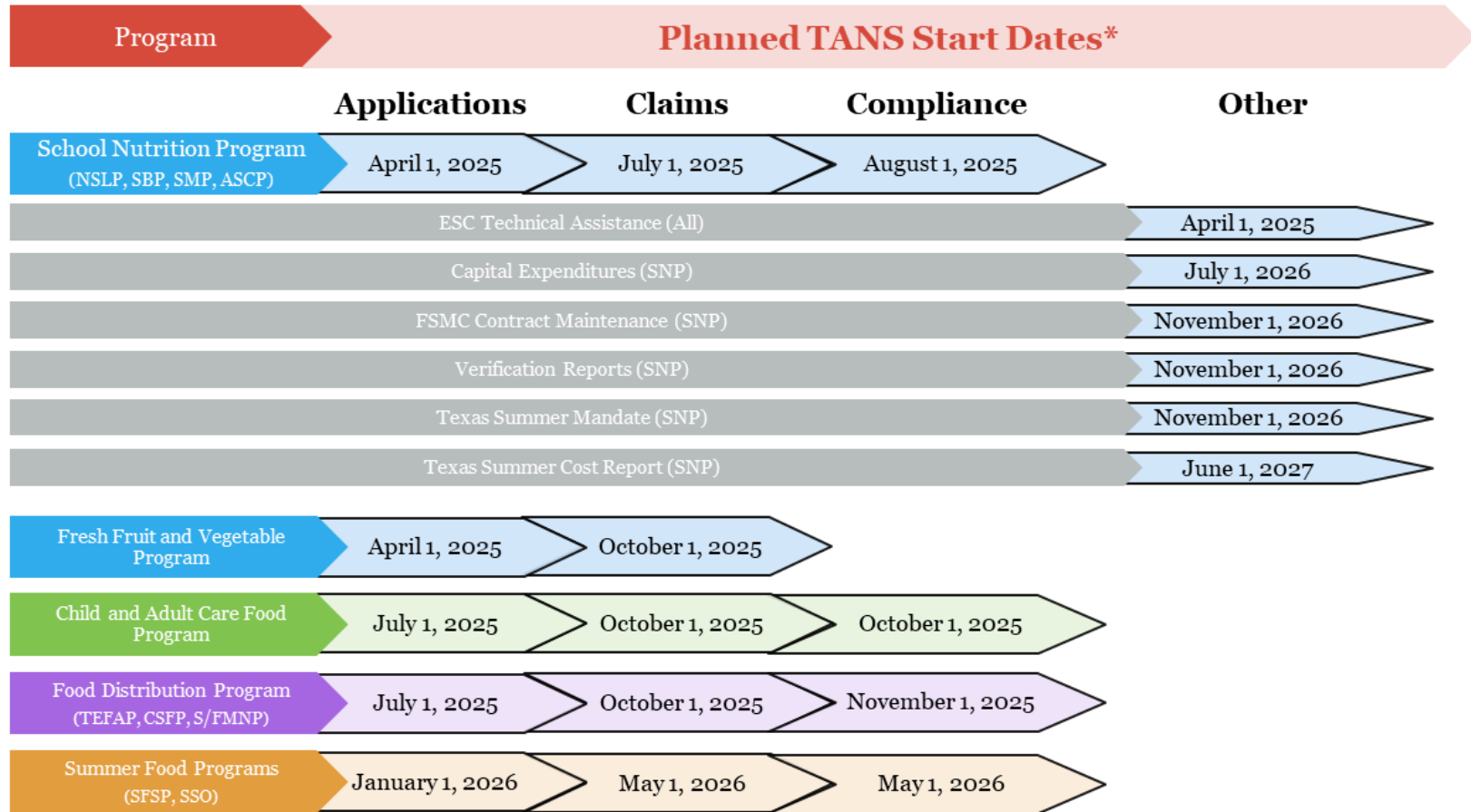

## What will training look like?

Training materials will fall into three broad categories with a heavier emphasis on self-service methods.

1. **Self-service:** on-demand short video tutorials, job aids, quick guides, manuals, and more.
2. **Instructor-led:** classroom and online trainings and demonstrations
3. **Computer lab:** hands on training labs and how-to sessions



## When will I receive training?

SNP applications training for organization users is planned for February and March 2025. Updates will be provided as materials are made available and trainings are scheduled.

Generally, organizations can expect to receive module-specific training 1-2 months prior to each launch date.

## Will my existing applications and data be moved to TANS?

TDA is transferring a very minimal amount of data to support a clean transition and higher quality data in TANS.

TDA will only populate key data including:

- organization name (formerly CE name)
- organization ID (formerly CE ID)
- site name(s)
- site ID(s)
- login IDs
- select data needed to complete program year 2026 calculations (EX: # of lunches served *two years prior* used for Severe Need Breakfast rate determinations in current program year)
  - *NOTE: this data may not be visible to users*

What won't be transferred?

- All other applications, claims, compliance, and other data will not be transferred or accessible in TANS.
- Sponsors will not be required to enter or upload data from previous years.
- Sponsors will need to populate data for program year 2026.
- Most data will rollover on future renewals.

*NOTE: TDA will retain access to all TX-UNPS data beyond system retirement in fulfillment of records retention requirements.*

## Will I still have access to reports and data?

Yes and no, depending on the point of access and the program year data needed.

### TX-UNPS Data - Program Years 2025 and Earlier

Users should take proactive action to ensure they have independent copies of necessary data for program years 2025 and earlier.

#### *TX-UNPS – reports and accounts*

Updates end 12/31/25

Access ends 12/31/25

#### *Open Data Portal (ODP) – datasets*

Updates end 12/31/25

Access will be continuous beyond 12/31/25

### TANS Data – Program Years 2026 and Beyond

#### *TANS – reports and accounts*

Access begins April 2025, limited to start

Export options built into system pages

Additional reports will be made accessible on a rolling basis

#### *Open Data Portal (ODP) – datasets*

Datasets for PY26 and beyond will be available

Format and terminology may change
