 - Yes. One user who is assigned to all four roles will see the Operations, Admin, and Reports tabs on the same screen with just one login.



- 3. As an Admin user are you allowed to give yourself the Order Manager authorization so that you can be a backup to ordering?
 - Yes.
- 4. Can one person be assigned to more than one duty?
 - Yes.
- 5. Can the User Admin and Org. Admin be the same person?
 - Yes.


- 6. What do small districts do with limited staff so that an administrator could do all roles if needed? This system seems to require multiple users just to function.
 - The User Admin can assign all four roles to themselves.


- 7. I appreciate these levels of access, but it seems that it will be very cumbersome for small districts who only have one or two people responsible for all duties.
 - The User Admin can assign all four roles to themselves.
 - The four roles can be split between two people.
 - However, there can only be two users assigned the role of User Admin.

Logging in When Assigned Multiple Roles

- 8. As you demonstrated you had to switch between logins, will that be the same if we are assigned all roles, or will one log in give all access to the one log in?
 - One user who is assigned to all four roles will see the Operations, Admin, and Reports tabs on the same screen with just one login.



- 9. It looks like separate logins required for each role. Is this the case?
 - In general, no. Separate logins **are not required** for each role. Users assigned to multiple roles will have one login.
 - For Direct-Ship schools only: there will be a separate login for receipting. One login is for the individual user role (User Admin, Order Manager, etc.). The second log in will be as a "Ship-To" for submitting receipts. The login screen will display the option to select which account you are logging into and will look similar to this:

- 10. How many user admins can you have?
 - Only two User Admins are allowed.
- 11. Can the User Admin complete the same functions as the order manager?
 - In general, if a functionality or capability is not included in the description on the User Role one-pager, that user role does not have that capability.
 - No, the User Admin cannot complete the same functions as the Order Manager.
 - The User Admin can assign the Order Manager role to themselves to gain these functions.

 - Unlimited

- 13. Who might have the Organization Administrator role? Is it necessary to have someone in this role?
 - It is necessary to have someone in this role to update the organization contact information.
 - Anyone in your organization can be assigned the role.
 - The User Admin can assign the Org Admin role to themselves if desired or needed.
- 14. For Organization Admin, what does maintain organization data mean? What is included in organization data?
 - Organization information is information such as address and contact information.



Troubleshooting Errors Login error

16. When I try to log into WBSCM, I receive a WBSCM Login Error such as below.



- You might have already completed Step 2 of the Action Required Email.
- Clear your Cache/History/Cookies by following these steps:
 - a) Log out of all programs and systems.
 - b) Close all Google Chrome tabs.
 - c) Open a new Google Chrome tab.
 - d) Click the three vertical dots in the upper right corner > Settings > Privacy and Security > Clear browsing data.
 - e) Select all boxes.
 - f) Select all time.
 - g) Clear data.
 - h) Navigate to the WBSCM Login page.

Already registered or account locked

17. I attempted to create my account and when I went to select Step 2 of the Action Required Email, it said my account was locked. I received the below error message:

Your WBSCM account is already registered OR your account may be locked.

- You have already completed the registration process and are attempting to click the same link again.
- Did you see and accept the WBSCM Rules of Behavior? If yes, your account is complete.
- Attempt to Clear your Cache/History/Cookies for "All Time".
- Ensure the User ID and Password are entered correctly.
