



#### Weighted Average Cost Adjustments

January Estimated Cost Values Utilized to Charge against Entitlement for the Next Program Year

- TDA adjusts the estimated cost values to the current costs in TX-UNPS twice during a PY
- November to coincide with the TLS update, and July to close out the previous PY.





#### Weighted Average Cost Adjustments Continued

- The costs per pound spiked for 64 percent of the USDA Foods.
- Costs per pound are still high.
- Available Entitlement will be adjusted in November with the TLS Update and Weighted Average Cost Adjustment.




